CONSUMER PAMPHLET LICENSE AGREEMENT

THIS AGREEMENT is made by and between the State Bar of Wisconsin (“State Bar”) and Purchaser (“You”) concerning the licensing of certain consumer pamphlets of the State Bar (individually, a “Pamphlet,” collectively the “Pamphlets”) for display and distribution on Your website. By completing the purchase of online versions of State Bar Pamphlets, you agree to the terms of this license agreement. Once the order is placed, You will receive an email receipt confirming the purchase of the Pamphlet(s), including a request to supply contact information and the URL address of the website hosting the Pamphlet(s).

In consideration of the mutual promises and covenants set forth below, the parties agree as follows:

- 1. Grant of Rights.** The State Bar grants to You, as a member of the State Bar of Wisconsin, a revocable, nonexclusive license to copy, display and electronically distribute the Pamphlets on Your web site. You may not sell the Pamphlets, print copies for distribution, or adapt the material in the Pamphlets for any purpose. You agree to display the Pamphlets in a manner that is tasteful and appropriate, in the State Bar’s sole determination, to the contents of the Pamphlets and to the State Bar’s sponsorship of the Pamphlets. From time to time the State Bar may publish updated versions of the Pamphlets. You agree to discontinue display and distribution of the outdated version of the applicable Pamphlet(s) on Your website. Pamphlets will be delivered in a Portable Document Format (PDF) or an HTML format either via email or the material may be downloaded from a hidden location on the State Bar’s website, at the State Bar’s discretion. The State Bar may, at any time and at its sole option, discontinue distribution of a Pamphlet. You agree to withdraw any Pamphlet from display and distribution on Your website at the State Bar’s request.
- 2. Term and Termination.** The license granted in this Agreement is an annual license. To renew this license, the State Bar will automatically bill You 60 days prior to the end of the term. Nonpayment by the end of the term terminates this agreement and You must promptly remove the Pamphlet(s) from Your website. This license also can be terminated by either party with ten (10) days written notice to the other if the other party materially breaches the terms of this Agreement. The State Bar will not refund the license fee in the event of such breaches or termination.
- 3. Compensation.** You will pay the State Bar an annual royalty of \$75 per Pamphlet, per website, for every Pamphlet that You license to display and electronically distribute on Your web site. The first annual royalty payment is payable when You enter into this Agreement. If a Pamphlet is withdrawn from distribution by the State Bar as provided in Section 1 above and is not replaced by an updated version, then the annual royalty for such Pamphlet will be prorated for that portion of the royalty year for which it was available to You for display and distribution on Your website. The State Bar may change its annual royalty for the Pamphlets on any anniversary of this Agreement with sixty (60) days written billing notice to You.
- 4. Copyright.** All title and copyrights in and to the Pamphlets and any copies of the Pamphlets are owned by the State Bar. You must treat the Pamphlets like any other copyrighted material.
- 5. No Warranty.** YOU UNDERSTAND THAT THE PAMPHLETS ARE PROVIDED ON AN “AS IS” BASIS, WITHOUT ANY WARRANTY OF ANY KIND FROM THE STATE BAR OR ANY OTHER PARTY AND STATE BAR AND ALL AUTHORS, CREATORS, DISTRIBUTORS AND OTHERS ASSOCIATED IN ANY WAY WITH SUCH PAMPHLETS HEREBY DISCLAIM ANY WARRANTIES WITH RESPECT THERETO, INCLUDING WITHOUT LIMITATION ANY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. YOU HEREBY AGREE TO WAIVE ANY CLAIMS YOU MAY HAVE AGAINST STATE BAR OR ANY AUTHORS, CREATORS, DISTRIBUTORS OR OTHERS ASSOCIATED WITH SUCH PAMPHLETS.
- 6. Assignment.** You may not assign or transfer any of Your rights under this Agreement.
